CALL TO ORDER

The meeting was called to order at 7:05 PM by Director Hunt who acted as chairperson.

CONSENT CALENDAR

1st Action: Director Evans made a motion to approve and file the May 26, 2009 Regular Board Meeting Minutes, the June 4, 2009 Special Board Meeting Minutes, and Correspondence. Director Levy seconded. Unanimously approved.

PAYMENT OF DISTRICT BILLS

2nd ACTION: Director Levy made a motion to approve Transmittal 06-09A, Directors compensation for the Board Meeting of May 26, 2009, \$250.00 total. Director Evans seconded. Unanimously approved.

3rd ACTION: Director Evans made a motion to approve payment of Transmittal 06-09B, District Bills, in the amount of \$4,731.02. Director Levy seconded. Unanimously approved.

4th ACTION: Director Levy made a motion to approve payment of Transmittal 06-09C, Utility Bills and Reimbursements, \$1,251.69. Director Evans seconded. Unanimously approved.

CHILDREN'S CENTER DIRECTOR'S REPORT

Children's Center Director Aimee Bryer submitted an updated Summer Session financial report to the Board. The month of July is looking good with approx. 45 students. Had staff meeting, hours have been cut back. Discussed safety issues with Staff. The Center may need to change operating hours to 9:00 AM - 6:00 PM because before-school care won't be needed since the school is closed. New fall students will need to put \$100 down for sign up.

The Directors requested a meeting with Director Bryer in July to further review and discuss the month of June's finances and to see if they will be able to support a Fall program.

GRANTS ADMINISTRATOR'S REPORT

Phil McWilliams asked the Board if they want to wanted to continue moving forward on the Solar Project based on a letter received with new information. An OK to proceed on the grant has been received from the state, but the funds are still frozen and the bids are probably invalid at this late date.

5th ACTION: Director Hunt made a motion to cancel the grant bidding process on the solar project. Director Evans seconded. Unanimously approved.

OTHER DISTRICT BUSINESS

The Directors discussed acknowledging County Roads and Supervisor Campbell with a Resolution for their assistance and cooperation with the community's suggestions to include rural appearance in the recent rework of two local bridges on Santiago Canyon Road. This will be further discussed at the next Regular Board Meeting.
