The meeting was called to order at 7:05 PM by Director Shepston, who acted as chairperson.

PUBLIC AND BOARD INPUT ON NON-AGENDIZED ITEMS

Phil McWilliams, organizer for the All Canyons Clean up and Inter-Coastal events thanked SMRPD for sponsoring the events. There was no cost to SMRPD.

Wendy Hayter asked if it were possible to change the no alcohol policy that is in place for the Silverado Community Center. Director Bates will check into it.

CONSENT CALENDAR

1st ACTION: Director Smisek made a motion to approve the Consent Calendar that included the Minutes of August 28, 2012, and Transmittals 09-12A, 09-12B, 09-12C. All Directors said Aye, unanimously approved.

CHILDRENS CENTER DIRECTORS REPORT

Director Aimee Bryer said things were going very well at the CC. Some things going on were, Story Hour with Ruth Lock, A Parent Workday, Tyler Humphreys is helping the kids plant a garden, Back to School Night. Fundraising events in the works are, North Explorer Fund Grant, Youth Garden Grant Home Depot, Ralph's Escript, Chili Cookoff. Canyon Land Conservation Fund donated \$1000 to the center. There is an Advisory committee meeting Oct 22.

OTHER DISTRICT BUSINESS

(A) Director Shepston stepped down from the SMRPD Presidents position because of a personal work schedule that has been overwhelming, consuming much of his time.

Hank Rodgers stood up and read a beautiful letter he wrote thanking Director Shepton for the good things he did during the time he spent as president.

Vice President Director Smisek thanked Director Shepston for his enthusiastic and excellent work on the Board.

Mr. Smisek took over the meeting, nominations were discussed. Director Smisek made a nomination. 2nd ACTION; Director Smisek nominated Director Bates to be the new SMRPD president. Director

Shepston seconded. Unanimously approved

Director Weel read a letter he wrote explaining his disappointments with the way things had been working with the Board. Mr. Weel asked if it were possible to elect two presidents? One would deal with the business aspects and laws, the other president would deal with environmental and trails issues. The Directors thought it might be a good idea and would look into the legalities of it.

The meeting commenced with Director Greg Bates residing as SMRPD president.

(B) Director Bates shared concern about a letter written by SMRPD that was read at a meeting with the county by Wendy Hayter. It was thought that Director Peterson would attend the meeting and represent SMRPD. The Directors agreed that it was a misunderstanding.

(C) Linda May reported they are working on the remaining punch list with CalEMA/FEMA for closing by the end of the month. There have been a few glitches, but all and all things are looking good. A last minute mold problem (that happened while workers were putting in the new unit) might hold things up for a little bit more.

(D) Director Smisek asked CC Director Aimee Bryer about donations still being received for the vandalism that occurred at the center. Ms Bryer has been working diligently to have the request removed but has had computer problems.

(E) Directors Bates and Weel are seeking a new Auditor for the District. Proposals have been received and are being reviewed. Director Bates appointed Director Weel to work with Bookkeeper Meghan Warner on the budget.

Director Smisek- new Fall brochures are in and will be mailed out the residents. It will also be ut on SMRPD's website.

An SMRPD calendar is being worked on.

Director Bates - A Messianic Jewish group have asked permission to congregate on Saturdays at the Silverado Community Center, Director Bates will consult counsel to see if it's ok.
