I am a Registered Nurse with my certification as an End of Life Doula. I worked as a Hospice Nurse for over 10 years and recently retired from a Case Management position in Orange County. I'd like to keep this first educational presentation very informal and open to discussions regarding end of life planning. The goal is to start a conversation to 'normalize' the dying process and think about what is important. The cost of not planning for this important life event, dying, can be devastating to our family members, health, and our community as a whole.

### Topics may include:

- Types of Advanced Directives
- What do you fear most about the dying process?
- What would a good death look like to you?
- What kind of support system do you want?
- Is it possible to find peace and acceptance at the end of life?
- Hospice services versus Doula services

If the community is open to this topic, I would be willing to have a presentation on specific topics every 3 months. 1.5 hours in length should work. We can make it shorter if needed
